**ORDER ESTABLISHING DEADLINES RELATING
TO RECEIVER'S SEVENTH REPORT ON CLAIMS EVALUATION
AND SETTING HEARING DATE FOR RECEIVER'S REPORT**

ON THIS 14 day of November, 2017, the Receiver's Seventh Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations filed on November 9, 2017, comes before the undersigned Judge of the District Court. The Court, being fully advised of the premises and for good cause shown, find and concludes that:

1. Deadlines should be established for: (a) a claimant to file an objection to the Receiver's recommendations as to the claimant's claim; and (b) the Receiver to file a response to any objections filed;
2. The Receiver's Report, including the recommendations contained therein, should be set for hearing; and
3. The attached Notice of Objection Deadline and Hearing on the Receiver's Seventh Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations is proper on all respects.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that any claimant having an objection to the Receiver's recommendations as set forth in the Receiver's Report filed in this proceeding on November 9, 2017, shall file such objection with this Court and serve a copy of the objection on the Receiver's counsel on or before December 9, 2017.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, on or before January 10, 2018, the Receiver shall file with this Court his response to each timely filed objection to the Receiver's recommendations.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver's Report, any timely filed objections to the Receiver's recommendations in the Receiver's Report, and any responses of the Receiver to such objections, are hereby set for hearing on January, 12th 2018 at 10:00 a.m. before the Honorable Lisa T. Davis, Judge of the District Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver serve the Notice by first class mail, postage prepaid, to each of the claimants whose claims are listed on Exhibit 1 to the Receiver's Report, with an exhibit setting forth the Receiver's recommendation in respect to the relevant claim, to the claimant's address stated on the claimant's proof of claim, or the most recent address for the claimant on the records of the Receiver.


