**NOTICE OF LIQUIDATION, PERMANENT INJUNCTION
AND DEADLINE FOR FILING PROOF OF CLAIM**

Notice is given that upon the Petition of Glen Mulready, Insurance Commissioner, as Receiver for Friday Health Plans of Oklahoma, Inc. and the Application for Order of Receivership, and Order of Liquidation with Finding of Insolvency, the District Court of Oklahoma County, Oklahoma, placed Friday Health Plans of Oklahoma, Inc. into receivership and on June 23, 2023 ordered the liquidation of Friday Health Plans of Oklahoma, Inc. (“FHPOK”) commencing on September 1, 2023.

In the Liquidation Order, the Court:

1. Enjoined and precluded FHPOK from conducting any further business;
2. Appointed Glen Mulready, Insurance Commissioner, as Receiver of FHPOK;
3. Appointed Donna Wilson as Assistant Receiver for the Company,
4. Appointed the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis, as Counsel for the Receiver,
5. Ordered the assignment and vesting of title as well as the possession of all of FHPOK’s assets in the Receiver.
6. Terminated all FHPOK policies as of August 31, 2023 and ordered the liquidation of FHOPK as of September 1, 2023.

Additionally, the Court ordered that policyholders, claimants, medical providers and creditors having claims against FHPOK must file a proof of claim, together with proof of loss with the Assistant Receiver no later than February 28, 2024. Any policyholder or medical provider who provided services to policyholders where aggregate claims to be paid post liquidation are less than the \$500,000 lifetime statutory limit need not file a Proof of Claim. If a policyholder's covered claims to be paid post liquidation exceed the statutory limit that policyholder will be notified by the Receiver to file a Proof of Claim. Proof of Claim forms received after February 28, 2024 will lose their statutory priority and may not receive a distribution of assets.
