**ORDER APPROVING RECEIVER’S THIRD REPORT ON CLAIMS EVALUATION
AND REQUEST FOR CONFIRMATION
OF RECEIVER’S RECOMMENDATION**

On this 22nd day of January, 2025, there came on for consideration the Receiver’s Third Report On Claims Evaluation and Request for Confirmation of Receiver’s Recommendation filed December 9, 2025. The Receiver was present through his Counsel, Kristopher E. Koepsel, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver’s Report and being fully advised in the premises, finds and orders the following:

1. This Court established February 28, 2024 as the deadline by which creditors must file their proof of claims against Friday Health Plans of Oklahoma, Inc. (“FHPOK”). The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against FHPOK. Any and all due process interests have been adequately protected by the Receiver’s notices.

2. The Receiver’s Third Report informs the Court that the remaining 2 timely filed

Class 3 claims are ready for adjudication. The Receiver's Third Report details the Receiver's recommendation that each of the remaining 2 claims in the Receiver's Third Report be denied. The Third Report further notifies the Court that this concludes the adjudication of all Class 3 Claims.

3. The Receiver's Third Report further informs the Court that there are three timely filed Class 6 Claims, six timely filed Class 7 Claims, and one late-filed Class 6 Claim, and that the Receiver believes the Estate's assets are insufficient to permit the payment of any Class 6 and Class 7 Claims. The Third Report details the Receiver's recommendation that the Court suspend any further adjudication until such a time that all claims with higher priority are paid, and the Receiver will notify the Court should assets become available for any Class 6 or Class 7 Claims and notify the Court and submit a Claims Report with recommendations for the treatment of those claims.

4. The Court allowed objections to be filed to the Receiver's Third Report no later than January 5, 2026. No objections were filed or submitted to the Receiver's Third Report.

5. The Receiver's recommendation of the denial of the timely and untimely filed Class 3 claims as fully described in the Receiver's Third Report, should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's recommended denial of each of the remaining 2 claims in the Third Report are hereby approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's recommended suspension of any further adjudication of any Class 6 and Class 7 Claims until such time that all claims with higher priority are paid as detailed in the Third Report is hereby

approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Third Report On Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed December 9, 2025 is approved in its entirety.


