**ORDER APPROVING AMENDED APPLICATION FOR ORDER AUTHORIZING  
THE RECEIVER TO NON-RENEW POLICIES**

Now on this 6 day of February, 2024, Glen Mulready's, Insurance Commissioner, as Receiver for Go Insurance Company ("Go Insurance"), Amended Application to Authorize the Receiver to non-renew policies of Go Insurance comes before me the undersigned Judge of the District Court. The Receiver appears through counsel, George M. Emerson, of Riggs, Abney, Neal, Turpen, Orbison & Lewis, and no one appears in opposition to the Application.

The Court finds that the Receiver's Amended Application For Order Authorizing the Receiver to non-renew policies of Go Insurance was filed January 19, 2024 and was properly served on all parties in interest on January 19, 2024, pursuant to 36 O.S. § 1938.

The Court further finds that no objections have been filed by the February 2, 2024 deadline and therefore the Court may enter an Order approving the application without a hearing, pursuant to 36 O.S. § 1938.

The Court further finds that this Court has authority to enter this Order authorizing the Receiver to non-renew each of the Go Insurance policies pursuant to 36 O.S. § 1902(A).

The Court further finds that non-renewal of the policies will assist the Receiver in removing the causes and conditions which have made the rehabilitation of Go Insurance necessary. 36 O.S. §§ 1910(A) & 1914 (E).


**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** that the Receiver's Amended Application to non-renew the Go Insurance policies is hereby approved.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the Receiver shall non-renew each Go Insurance policy at its next annual renewal date or six months after the last renewal date whichever is earlier.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the Receiver shall notify each Go insured, by mailing a notice of non-renewal via U.S. post to the insured's mailing address as shown on the records of Go Insurance at least sixty (60) days prior to the non-renewal.
