RECEIVER'S REPORT ON CLAIMS EVALUATION AND REQUEST FOR CONFIRMATION OF RECEIVER'S RECOMMENDATION

Glen Mulready, Insurance Commissioner, as Receiver (the "Receiver") for Heritage National Insurance Company ("HNIC"), through Assistant Receiver, Donna L. Wilson, pursuant to 36 O.S. §1918 respectfully submits to this Court the Receiver's Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation, and in support thereof, would show the Court as follows:

BACKGROUND

- 1. On March 15, 2002, this Court entered its Order Appointing Receiver for Heritage National Insurance Company and Granting Injunctive Relief ("Receivership Order"), in which the Court appointed the Insurance Commissioner as Receiver for the HNIC estate.
- 2. Title 36 O.S. § 1930 requires notice be given to all persons who may have claims against the insurer and who have not filed proper proofs thereof to present the same at a place specified in the notice in a manner determined by the court.

- 3. On April 10, 2002, this Court approved a Proof of Claim form to be issued to the creditors of HNIC and for publication or similar dissemination designed to provide notice to creditors or potential creditors of HNIC and established August 15, 2002 as the final date for presentment of claims against the HNIC estate.
- 4. The Assistant Receiver distributed 49,250 notices of the insolvency proceedings and the claims bar date, to all known persons or entities that may have a claim against HNIC, at their last known address.
- 5. The Assistant Receiver reports 670 Proof of Claims were timely filed on or before August 15, 2002. Additionally, 44 Proof of Claims were untimely filed after August 15, 2002.
- 6. Title 36 O.S. § 1927.1(B) (the "priorities statute") establishes a priority system for distribution of assets of the estate of an insolvent insurer.
- 7. On December 11, 2009, this Court approved Class 2 claims in the amount of \$1,544,306.73 by the Oklahoma Life and Health Insurance Guaranty Association ("OLHIGA") and \$431,223.97 of the Texas Life, Accident, Health & Hospital Service Insurance Guaranty Association, now known as Texas Life and Health Insurance Guaranty Association ("TLHIGA").
- 8. The December 11, 2009 Order further found that Class 2 expenses are ongoing, and additional Class 2 claims may be filed in the future.
- 9. This Court previously adjudicated five other Proof of Claims (4 timely filed, one untimely filed).

RECOMMENDATION ON CLAIMS

10. Pursuant to 36 O.S. § 1927.1, Class 2 is "The administrative expenses of guaranty associations." The Receiver recommends approval of supplemental Class 2 claims of \$86,949.22 by OLHIGA and \$3,168.24 by TLHIGA.

11. Further, 36 O.S. § 1927.1 provides:

- a. Class 3 is "All claims under policies including claims of the federal or any state or local government for losses incurred ("loss claims") including third-party claims, claims for unearned premiums, all claims of a guaranty association for payment of covered claims or covered obligations of the insurer and all claims of a guaranty association for reasonable expenses other than those included in Class 2."
- b. Class 6 is "Claims of any person, including claims of state or local governments, except those specifically classified elsewhere in this section."
- 12. The Receiver recommends approval of the Class 3 claim of OLHIGA in the amount of \$13,505,115.19 and the Class 3 claim of TLHIGA in the amount of \$5,542,037.60
- 13. The Receiver has analyzed the claims reflected on Exhibit 1 thru Exhibit 4 and recommends the classification of each of the claims for the purposes of 36 O.S. §1927.1.
- 14. Exhibit 1 reflects those proof of claims timely filed for Class 3 claims. The "Amount Claimed" column reflects the amount that the Class 3 claimant has sought through the particular claim. The "Amount Recommended" column sets forth the amount the Receiver recommends that the Court allow as to the particular Class 3 claim.
- 15. Exhibit 2 reflects those proof of claims timely and untimely filed for Class 3 claims.

 The "Amount Claimed" column reflects the amount that the Class 3 claimant has sought through the particular claim. The Receiver recommends the denial of all Class 3 claims on Exhibit 2. The "Amount Recommended" column indicates the Receiver recommends denial of that particular Class 3 claim.
 - 16. Exhibit 3 reflects those proof of claims timely and untimely filed for Class 6 claims.

The Receiver is not recommending an "Amount Recommended" for Class 6 as the estate assets are insufficient to make distributions to these claimants.

- 17. Exhibit 4 reflects those proof of claims untimely filed for Class 7 claims. The Receiver is not recommending an "Amount Recommended" for Class 7 claims as the estate assets are insufficient to make distributions to these claimants.
- 18. The Proof of Claim form filed by each claimant contains the following language: "IF YOU HAVE A CHANGE OF ADDRESS, YOU MUST INFORM THE ASSISTANT RECEIVER OF THE NEW ADDRESS IN ORDER TO RECEIVE ANY PAYMENT THAT MIGHT BE DUE." To the extent any Notice of this proceeding is returned undeliverable, the Receiver asks the Court to find that the due process rights of the claimant have not been impaired and to order approval of the Receiver's recommendation of their claim without further attempts to give actual notice.
- 19. In compliance with the due process required by 36 O.S. § 1918, the Receiver asks the court to set a hearing on the claims and establish a date certain for filing an objection to the Receiver's recommendation.
- 20. The recommended denial by the Receiver of any timely filed proof of claim does not alter the statutory obligation, if any, of the OLHIGA or similar associations in other states, to provide coverage of "covered claim" as defined by each association's applicable state law.

WHEREFORE, the Receiver prays that this Court enter an Order for the following: 1) order that notice of opportunity to object and be heard on the claims on the Exhibits be given by the Receiver; 2) establish a date for filing an objection to the recommendation of the Receiver; 3) establish a date for hearing the Receiver's recommendation to the court and any objections thereto; 4) upon hearing any objections thereto, enter an order approving the Receiver's Report and 5) such

other relief as the Court deems appropriate.
