**ORDER APPROVING RECEIVER'S REPORT ON CLAIMS EVALUATION
AND CONFIRMING RECEIVER'S RECOMMENDATIONS**

On this 24th day of June, 2021, there came on for consideration the Receiver's Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed May 4, 2021. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver's Report, the Objection submitted to the Receiver by Duane Geasland (POC No. 1541) and the Receiver's Response to the Objection, and being fully advised in the premises, finds and orders the following:

1. This Court established August 15, 2002 as the deadline by which creditors must file their proof of claims against the Heritage National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Heritage National Insurance Company. Any and all due process interests have been adequately protected by the Receiver's notices.

2. The Receiver's Report informed the Court that certain Class 3, Class 6, and Class

7 claims were ready for adjudication. The Receiver's Report detailed the Receiver's recommendation on each of the claims listed in the Receiver's Report.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than May 28, 2021.

4. Duane Geasland submitted an objection. The Objection is attached as an Exhibit to the Receiver's Response to the Objection regarding Proof of Claim 1541.

5. The Court finds the objection of Duane Geasland (POC No. 1541) should be denied.

6. The Receiver's recommendation of the Class 3, Class 6, and Class 7 claims as fully described in the Receiver's Report should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the objection to the denial of Proof of Claim by Duane Geasland (POC No. 1541) is overruled and the Receiver's recommended denial is approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's recommendation on all claims included in the Receiver's Report are approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed May 4, 2021, is approved in its entirety.
