**ORDER APPROVING RECEIVER'S FIRST REPORT  
ON CLAIMS EVALUATION AND CONFIRMATION OF  
RECEIVER'S RECOMMENDATION**

On the 15<sup>th</sup> day of June, 2017, there came on for consideration the Receiver's First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed on April 17, 2017. The Receiver was present through his Counsel and no one appears in opposition. The Court having examined the Receiver's Report and no Objections were filed, and being fully advised in the premises, finds and orders the following:

1. This Court established October 15, 2016 as the deadline by which creditors must file their proof of claims against the New Crown Management Corporation, Inc., d/b/a Crown Hill Cemetery ("Crown Hill"), The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Crown Hill. Any and all due process interests have been adequately protected by the Receiver's notices.

2. The Receiver's First Report informs the Court that 9 Class 6 claims are ready for adjudication. The Receiver's First Report details the Receiver's recommendation for each of the 9 Class 6 claims.

3. The Receiver's recommendation of the approval of the timely filed Class 6 claims, as fully described in the Receiver's First Report, should be and is hereby approved. All Class 1 – Class 5 Claims shall be paid in full prior to the payment of any Class 6, as provided by 36 O.S. § 1927.1,

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** that the Receiver's First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed April 17, 2017 is approved in its entirety.
