**ORDER APPROVING RECEIVER’S THIRD REPORT ON CLAIMS EVALUATION AND
CONFIRMATION OF RECEIVER’S RECOMMENDATION**

On the 4th day of October, 2018, there came on for consideration the Receiver's Third Report on Claims Evaluation and Request for Confirmation of Receiver’s Recommendation filed on August 8, 2018. The Receiver was present through his Counsel and no one appears in opposition. The Court, having examined the Receiver’s Report and all Objections that were filed, and being fully advised in the premises, finds and orders the following:

1. This Court established October 15, 2016 as the deadline by which creditors must file their proof of claims against the New Crown Management Corporation, Inc., d/b/a Crown Hill Cemetery (“Crown Hill”). The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Crown Hill. Any and all due process interests have been adequately protected by the Receiver’s notices.

2. The Receiver’s Third Report informs the Court that the estate does not have sufficient funds to pay the Class 6 timely proof of claims. In light of the insufficient funds, the Receiver recommends that he court find that the two (2) claims filed after October 15, 2016 claims

bar date to have been filed untimely and, as such, that no further funds be expended valuing these claims.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Third Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed August 8, 2018 is approved in its entirety.


