**NOTICE OF LIQUIDATION, PERMANENT INJUNCTION  
AND DEADLINE FOR FILING PROOF OF CLAIM**

Notice is given that upon the Petition of Glen Mulready, Insurance Commissioner, as Receiver for Oklahoma Schools Risk Management Trust (“OSRMT”) and the Agreed Order Placing Insurer into Receivership, Appointing Receiver, Order of Liquidation, Injunctive Relief and Approving of Notice of Liquidation, Proof of Claim Form and Reporting Deadlines, the District Court of Oklahoma County, Oklahoma, placed OSRMT into receivership and on the 28 day of June 2024.

In the Agreed Order, the Court:

1. Enjoined and precluded OSRMT from conducting any further business,
2. Appointed Glen Mulready, Insurance Commissioner, as Receiver of OSRMT,
3. Appointed Donna Wilson as Assistant Receiver for the Company,
4. Appointed the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis, as Counsel for the Receiver,
5. Ordered the vesting of title as well as the possession of all of OSRMT’s assets in the Receiver, and
6. Terminated all OSRMT policies not previously cancelled, non-renewed or otherwise, terminated and/or certificates of insurance upon entry of the order.

Additionally, the Court ordered that policyholders, claimants, and other creditors having claims against OSRMT must file a proof of claim, together with proof of loss with the Assistant Receiver no later than Monday, October 21, 2024.
