**ORDER APPROVING RECEIVER’S FIRST REPORT ON CLAIMS READY TO BE  
ADJUDICATED AND REQUEST FOR CONFIRMATION  
OF RECEIVER’S RECOMMENDATION**

On this 20th day of March, 2025, there came on for consideration the Receiver’s First Report On Claims Ready to be Adjudicated and Request for Confirmation of Receiver’s Recommendation filed February 14, 2025. The Receiver was present through his Counsel, Robert A. Nance, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver’s Report and being fully advised in the premises, finds and orders the following:

1. This Court established October 21, 2024 as the deadline by which creditors must file their proof of claims against Oklahoma Schools Risk Management Trust, (OSRMT). The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against OSRMT. Any and all due process interests have been adequately protected by the Receiver’s notices.

2. The Receiver’s First Report informs the Court that 1 timely filed Class 3 claim is ready for adjudication. The Receiver’s First Report details the Receiver’s recommendation that

claim be allowed.

3. The Court allowed objections to be filed to the Receiver's First Report no later than February 28, 2025. No objections were filed or submitted to the Receiver's First Report.

4. The Receiver's recommendation of the approval of the timely filed Class 3 claim as fully described in the Receiver's First Report, should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.


