**ORDER DETERMINING CLAIMS, APPROVING RECEIVER'S
FIRST REPORT ON CLAIMS AND OVERRULING OBJECTIONS**

On the 16th day of July, 2012, there came on for hearing the Receiver's First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations filed with the Court on April 13, 2012 ("Receiver's Report") and the objections to the Receiver's Report. The Receiver appeared through his counsel, John M. O'Connor, of the law firm of Newton, O'Connor, Turner & Ketchum, P.C. In support of the Receiver's Report, the Receiver presented evidence at the hearing including the sworn testimony of the Assistant Receiver, Mark D. Tharp, and certain Exhibits. No one appeared at the hearing in opposition to the Receiver's Report.

The Court, for good cause shown, and being fully advised, finds and concludes as follows:

1. The Receiver made good faith and sufficient efforts to determine the identity of all persons who may have claims against Park Avenue Property and Casualty Insurance Company f/k/a Providence Property and Casualty Insurance Company ("Park Avenue") and

mailed approximately 27,000 Proof of Claim packets to such potential claimants, including notice of the opportunity to file a claim before the February 15, 2011 claims bar date.

2. A total of 413 timely proofs of claims were submitted to the Receiver.

3. The Receiver's Report presents the Receiver's recommendations as to 360 of such claims, including three hundred-six (306) Class 3 claims, forty-nine (49) Class 6 claims and five (5) claims which were not timely filed.

4. On April 27, 2012, the Receiver mailed written notice to each of the claimants whose claims are addressed in the Receiver's Report. Such notice stated the deadline for filing objections to recommendations in the Receiver's Report, as well as the date, time and place of the Court's hearing on the Receiver's Report. Additionally, the notice contained the specific recommendations of the Receiver as to the claim of the claimant to whom the notice was sent.

5. The Notice which the Receiver sent to each such claimant was the Notice approved by the Court on April 27, 2012, and the Receiver's notices have adequately protected any and all due process interests.

6. The Receiver received four objections to the recommendations contained in the Receiver's Report. The claimants submitting objections include: (a) Claimant Ted Hancock (PAPC – 00193); (b) Claimant Sonia Pimentel (PAPC – 0400); (c) Claimant David Madison (PAPC – 00290); and (d) Claimant Sandra Flores (PAPC-00215) (collectively the "Objecting Claimants").

7. The objections of the Objecting Claimants are without merit and should be overruled.

8. The Receiver's recommendations as to the 360 claims addressed in the Receiver's Report, as detailed in Exhibits 1 through 4 of the Receiver's Report, are supported by the law

and are the facts and the Receiver's recommendations should be approved by this Court.

9. The denial of any timely-filed proof of claim included in the Receiver's Report does not alter the statutory obligation, if any, of the Oklahoma Property & Casualty Insurance Guaranty Association or other applicable state guaranty fund, to provide indemnity and defense of a "covered claim" as defined by the Oklahoma Property & Casualty Insurance Guaranty Association Act, 36 O.S. § 2004(7), or other applicable statute.

10. There is no just reason to delay the entry of a final, appealable Judgment as to the matters hereby adjudicated. Good cause exists to enter this order as a final appealable Order, pursuant to 12 O.S. § 994(A).

11. This is a final and appealable order as to the matters addressed herein for purposes of 36 O.S. § 1902 (H) and in accordance with 36 O.S. § 1918 (D).

12. Pursuant to the Receiver's request, the Receiver shall identify the claims on the attached Exhibits by reference to the claim number and shall redact from the Exhibits the names of the claimants. When no amount is stated in the "Amount Allowed" column on an Exhibit with respect to a claim, the claim is disallowed.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that the Receiver's Report is hereby **APPROVED** and the recommendations contained therein, as set forth in the attached Exhibits 1 through 4 of the Receiver's Report, are hereby **ACCEPTED** and **APPROVED** in their entirety.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that each of the claims addressed in the Receiver's Report identified on Exhibit 1 attached to this Order is properly classified as a Class 3 claim under 36 O.S. § 1927.1 and is allowed, allowed in part, or disallowed, in accordance with the Receiver's recommendations, as reflected in the "Amount

Allowed" column on Exhibit 1 attached to this Order.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that each of the claims addressed in the Receiver's Report identified on Exhibit 2 attached to this Order is properly classified as a Class 6 claim under 36 O.S. § 1927.1 and is allowed, allowed in part, or disallowed, in accordance with the Receiver's recommendations, as reflected in the "Amount Allowed" column on Exhibit 2 attached to this Order.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that each of the claims addressed in the Receiver's Report identified on Exhibit 3 attached to this Order is an untimely-filed claim under 36 O.S. § 1930 and shall be allowed in the amount the Receiver has recommended, if any, as reflected in the "Amount Allowed" column on Exhibit 3 attached to this Order.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the referenced objections filed by the Objecting Claimants are overruled and denied.

IT IS FINALLY ORDERED, ADJUDGED, AND DECREED that this Order is hereby certified, pursuant 12 O.S. § 994(A), to be a final, appealable Order and, accordingly, the Court Clerk is hereby directed to file this instrument as a final, appealable Order.



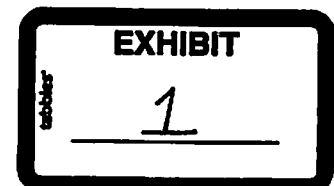

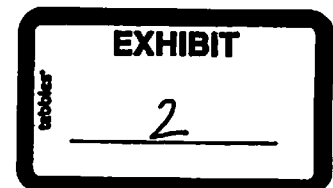
