ORDER EXTENDING STAY OF LITIGATION

Now on this 17 day of May, 2013, the Application To Extend Stay of Litigation filed by John D. Doak, Receiver for Pride National Insurance Company (PNIC), comes on before me the undersigned Judge of the District Court. The Receiver appears through counsel, George M. Emerson of Riggs Abney Neal Turpen Orbison & Lewis and no one appears in opposition to the Application. Upon review of the Application, finding that proper notice of the Application has been given and there being no objections thereto, the Court finds the Application should be granted.

IT IS THEREFORE ORDERED that pursuant to 36 O.S. § 1904(B), the Court extends the stay of litigation ordered in the Court's March 8, 2013 Order Placing Insurer into Receivership, Appointing Receiver, Issuance of Injunction and Order for Rehabilitation and Consent Thereto (Receivership Order) against PNIC's insureds. The Court's stay of litigation against PNIC's insureds only shall be extended for another ninety days until August 8, 2013 or until further order of this Court.

IT IS FURTHER ORDERED that the Court's order of March 8, 2013 enjoining prosecution of any actions or litigation by all persons or entities (including secured


creditors, unsecured creditors, claimants and/or litigants) involving PNIC (whether as a plaintiff or defendant), except as modified by the Court's order of March 20, 2013, shall remain in full force and effect until further order from this Court.

IT IS FURTHER ORDERED that in the interest of judicial economy and until further order from this Court, entry of this Order, by filing with the clerk of any court in this state with competent jurisdiction along with an affidavit of counsel of record that a PNIC's insured is a named party in the lawsuit, will serve to stay any action for an additional period of ninety days, against PNIC's insured only, either commenced or in the process of being prosecuted without further notice or the necessity of a separate motion to stay a pending or commenced action. This Order shall be given full faith and credit by sister states pursuant to the United States Constitution, Article IV, § 1.
