IT IS THEREFORE ORDERED, ADJUDGED and DECREED that the extension of the claims filing, claim reporting and evaluation plan deadlines established in this Court's Order filed August 9, 2013 is hereby approved and that the new deadlines are as follows:

8/07/14		Receiver's First Claims Evaluation and Request for Confirmation due (on claims due to be adjudicated). Receiver's Supplemental Claims Evaluations and Requests

for Confirmation (on subsequently evaluated claims ready to be adjudicated) will be submitted within every six (6) months thereafter, beginning with 3/06/15, or earlier if practicable.


All other matters included in the Court's Order of August 9, 2013, not specifically modified herein, remain in full effect.


