ORDER APPROVING RECEIVER'S SECOND REPORT ON CLAIMS EVALUATION AND CONFIRMING RECEIVER'S RECOMMENDATION

On this 30th day of April, 2015, there came on for consideration the Receiver's Second Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed March 6, 2015. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver's Report, the Objection filed by Veronica Duncan (POC No. 1727) and the Receiver's Response to Objection Regarding Proof of Claim 1727, and being fully advised in the premises, finds and orders the following:

- 1. This Court established April 7, 2014 as the deadline by which creditors must file their proof of claims against the Pride National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Pride National Insurance Company. Any and all due process interests have been adequately protected by the Receiver's notices.
- 2. The Receiver's Second Report informs the Court that 52 Class 3 claims are ready for adjudication. The Receiver's Second Report details the Receiver's recommendation that

each of the 52 Class 3 claims in the Receiver's Second Report be denied.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Second

Report of an opportunity to object to the Receiver's recommendation for the denial of the claim

by filing a written objection with the Court no later than April 6, 2015.

4. One objection, by Veronica Duncan, was submitted to Counsel for the Receiver,

but not filed with the Court. The Objection is attached as an Exhibit to the Receiver's Response

to the Objection regarding Proof of Claim 1727.

5. The Court finds the objection of Veronica Duncan (POC No. 1727) should be

denied as she has failed to substantiate that her purported injuries are the fault of a Pride insured

or are covered under a Pride policy. Furthermore, the statute of limitations has expired without

any suit being filed by Ms. Duncan against the Pride insured.

6. The Receiver's recommendation of the denial of the timely filed Class 3 claims,

as fully described in the Receiver's Second Report, should be and is hereby approved. All Class

1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36

O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the objection to

the denial of Proof of Claim by Veronica Duncan (POC No. 1727) is overruled and the

Receiver's recommended denial is approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's

Second Report on Claims Evaluation and Request for Confirmation of Receiver's

Recommendation filed March 6, 2015 is approved in its entirety.
