

3. The Receiver gave proper notice to all claimants listed in the Receiver's Sixth Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than March 31, 2017.

4. No written objections have been filed nor have any Claimants contacted Counsel or the Receiver's office in opposition to the Receiver's Sixth Report.


5. The Receiver's recommendation of the denial of the 15 Class 3 claims, as described in the Receiver's Sixth Report should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Sixth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed March 6, 2017, denying 15 Class 3 Claims is approved in its entirety.


