ORDER APPROVING RECEIVER'S EIGHTH REPORT ON CLAIMS EVALUATION AND CONFIRMING RECEIVER'S RECOMMENDATION

On this 20th day of April, 2018, there came on for consideration the Receiver's Eighth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed March 7, 2018. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver's Report and being fully advised in the premises, finds and orders the following:

- 1. This Court established April 7, 2014 as the deadline by which creditors must file their proof of claims against the Pride National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Pride National Insurance Company. Any and all due process interests have been adequately protected by the Receiver's notices.
- 2. The Receiver's Eighth Report informed the Court that 27 Class 3 claims and 31 Class 6 claims were ready for adjudication. The Receiver's Eighth Report detailed the Receiver's recommendation that each of the 58 claims in the Receiver's Eighth Report be

denied.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Eighth

Report of an opportunity to object to the Receiver's recommendation for the denial of the claim

by filing a written objection with the Court no later than April 2, 2018.

4. No written objections have been filed nor have any Claimants contacted Counsel

in opposition to the Receiver's Eighth Report. One informal objection to the denial of POC 1380

was received by the Receiver. No documentation was provided with the objection that altered

the Receiver's recommended denial of POC 1380. The Receiver's office notified the Claimant

that the recommended denial of the claim had not changed.

5. The Receiver's recommendation of the denial of the 27 Class 3 claims, including

the denial of POC 1380, and the 31 Class 6 claims, as described in the Receiver's Eighth Report

should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the

payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's

Eighth Report on Claims Evaluation and Request for Confirmation of Receiver's

Recommendation filed March 7, 2018, denying 27 Class 3 claims and 31 Class 6 claims is

approved in its entirety.
