**ORDER APPROVING RECEIVER'S NINTH REPORT ON CLAIMS EVALUATION
 AND CONFIRMING RECEIVER'S RECOMMENDATION**

On this 1st day of November, 2018, there came on for consideration the Receiver's Ninth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed September 7, 2018. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver's Report and being fully advised in the premises, finds and orders the following:

1. This Court established April 7, 2014 as the deadline by which creditors must file their proof of claims against the Pride National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Pride National Insurance Company. Any and all due process interests have been adequately protected by the Receiver's notices.

2. The Receiver's Ninth Report informed the Court that 12 Class 3 claims were ready for adjudication. The Receiver's Ninth Report detailed the Receiver's recommendation that each of the 12 claims in the Receiver's Ninth Report be denied.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Ninth Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than October 1, 2018.

4. No written objections have been filed in opposition to the Receiver's Ninth Report.

5. One informal objection to the denial of POC 1487 was received by the Receiver. Upon the further review of the informal objection, the Receiver withdraws the recommended denial of POC 1487 until further notice.

6. The Receiver's recommendation of the denial of the remaining 11 Class 3 claims as described in the Receiver's Ninth Report should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Ninth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed September 7, 2018, denying 11 Class 3 claims is approved and the Receiver's withdrawal of the recommendation on POC 1487 is approved.
