**ORDER APPROVING RECEIVER’S TENTH REPORT ON CLAIMS EVALUATION
AND CONFIRMING RECEIVER’S RECOMMENDATION**

On this 25th day of April, 2019, there came on for consideration the Receiver’s Tenth Report on Claims Evaluation and Request for Confirmation of Receiver’s Recommendation filed March 7, 2019. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver’s Report, the Objection submitted to the Receiver by Dustin Price (POC No. 1204) and the Receiver’s Response to the Objection, and being fully advised in the premises, finds and orders the following:

1. This Court established April 7, 2014 as the deadline by which creditors must file their proof of claims against the Pride National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Pride National Insurance Company. Any and all due process interests have been adequately protected by the Receiver’s notices.

2. The Receiver’s Tenth Report informed the Court that five (5) Class 3 claims were ready for adjudication. The Receiver’s Tenth Report detailed the Receiver’s recommendation

that each of the five (5) claims in the Receiver's Tenth Report be denied.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Tenth Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than April 8, 2019.

4. Dustin Price submitted an objection to the Receiver but did not file it with the Court. The Objection is attached as an Exhibit to the Receiver's Response to the Objection regarding Proof of Claim 1204.

5. The Court finds the objection of Dustin Price (POC No. 1204) should be denied as he never established the liability of the Pride insured. As a result of he is not entitled to share in the funds of the estate pursuant to 36 O.S. § 1927.1(B) (3).

6. The Receiver's recommendation of the denial of the five (5) Class 3 claims as fully described in the Receiver's Tenth Report should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the objection to the denial of Proof of Claim by Dustin Price (POC No. 1204) is overruled and the Receiver's recommended denial is approved.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Tenth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed March 7, 2019, denying five (5) Class 3 Claims is approved in its entirety.


