**ORDER APPROVING RECEIVER’S FIFTEENTH REPORT ON CLAIMS
EVALUATION AND CONFIRMING RECEIVER’S RECOMMENDATION**

On this 21st day of October, 2021, there came on for consideration the Receiver’s Fifteenth Report on Claims Evaluation and Request for Confirmation of Receiver’s Recommendation filed September 1, 2021. The Receiver was present through his Counsel, George M. Emerson, of the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis and no one appears in opposition. The Court having examined the Receiver’s Report, the Objections thereto and the Receiver’s Responses regarding the objections, and being fully advised in the premises, finds and orders the following:

1. This Court established April 7, 2014 as the deadline by which creditors must file their proof of claims against the Pride National Insurance Company. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against Pride National Insurance Company. Any and all due process interests have been adequately protected by the Receiver’s notices.

2. The Receiver’s Fifteenth Report informed the Court that Receiver has recommended the partial allowance of 1 Class 3 claim and the denial of 34 Class 3 Claims.

3. The Receiver gave proper notice to all claimants listed in the Receiver's Fifteenth Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than September 22, 2021.

4. Two objections to the Receiver's report were filed. Ronald Mayes objected to the Receiver's recommended denial of proof of claim 1487. Also, Clayton Prairie Chief filed an objection to the Receiver's recommended denial of proof of claim 1760.

5. The Court finds the objections of Ronald Mayes (POC No. 1487) and Clayton Prairie Chief (POC No. 1760) should be denied. As a result neither claim shall share in the disbursement of estate funds, if any, pursuant to 36 O.S. § 1927.1(B) (3).


6. The Receiver's recommendation of the partial allowance of 1 Class 3 claim and the denial of 34 Class 3 Claims as described in the Receiver's Fifteenth Report should be and is hereby approved. All Class 1 – Class 2 Claims shall be paid in full prior to the payment of any Class 3, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Objections of Ronald Mayes relating to POC No. 1487 and Clayton Prairie Chief relating to POC No. 1760 are denied.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver's Fifteenth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed September 1, 2021, is approved.
