RECEIVER'S REPORT OF TIMELY FILED CLAIMS

COMES NOW, the State of Oklahoma, *ex rel.*, John D. Doak, Insurance Commissioner, as statutory receiver of Red Rock Insurance Company f/k/a BancInsure and Nestor Romero, Assistant Receiver (collectively "Receiver"), and pursuant to the Order entered October 24, 2014, files this Report of Timely Filed Claims:

- 1. By Order dated August 21, 2014 ("Liquidation Order"), the Court directed the Receiver to proceed with liquidating Red Rock Insurance Company ("Red Rock"). The Court further directed the Receiver to notify all persons who have claims against Red Rock of the claims filing bar date in a form approved by the Court.
- 2. By virtue of the Court's Order, title to all property of Red Rock was vested in the Receiver and the Receiver was charged with the duty of marshalling the assets of Red Rock, liquidating those assets and distributing all remaining assets in accordance with the statutory prioritization of allowed claims.
- 3. On October 24, 2014, the Court entered an Order Approving Receiver's Combined Application for Approval of (a) Notice of Liquidation, (b) Form of Proof of Claim

and Instructions, and (c) Form of Unconditional Assignment and Application for Approval of Receiver's Claims Reporting and Evaluation Plan.

- 4. The Liquidation Order required the Receiver to provide notice to all persons holding claims against Red Rock to file proofs of claims. Such Notice is also mandated by 36 O.S. §1930. The October 24, 2014, Order approved the form of the notice and proof of claims. The Receiver took all reasonable efforts to determine the identity of all persons who may have claims against Red Rock and to provide them with notice to allow them the opportunity to file a claim before the February 20, 2015, claims bar date established by the Court.
- 5. The Receiver distributed 7,111 proof of claim packets to potential claimants. If a claim packet was returned undeliverable, the Receiver made every effort to locate an updated address. Approximately 440 claim packets were resent to updated addresses.
- 6. Pursuant to 36 O.S. §1918 and the Order of October 24, 2014, the Receiver reports that 504 proofs of claim were timely filed in an aggregate claimed amount of \$274,171,418.30.
 - 7. Of these claims, 175 are unstated or undetermined as to the claimed amount.
 - 8. The claims are comprised of the following categories:

- 9. There have also been 14 untimely filed claims totaling \$426,331.56. A list of untimely filed claims is attached as Exhibit B.
- 10. 36 O.S. §1918 provides that the Court may establish a time period within which the Receiver shall advise the Court of the Receiver's recommendation and evaluation of the claims. Pursuant to the Order of October 24, 2014, entered in this action, the Receiver must file the "First Claims Evaluation and Request for Confirmation" on or before June 22, 2015.

WHEREFORE, the Receiver respectfully submits this Report of Timely Filed Claims.
