**ORDER ESTABLISHING DEADLINES RELATING  
TO RECEIVER'S FIRST REPORT ON CLAIMS EVALUATION  
AND SETTING HEARING DATE FOR RECEIVER'S REPORT**

On this 22<sup>nd</sup> day of June, 2015, the Receiver's First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations ("Receiver's Report") filed on June 22, 2015, comes before the undersigned Judge of the District Court. The Court, being fully advised of the premises and on good cause, finds and concludes:

1. Deadlines should be established for: (a) a claimant to file an objection to the Receiver's recommendations as to the claimant's claim; and (b) the Receiver to file a response to any objections filed;
2. The Receiver's Report, including the recommendations contained therein, should be set for hearing, and:

3. The Notice of Hearing on the Receiver's First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations (the "Notice") attached as Exhibit 5 to the Receiver's Report is proper in all respects.

**IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED** that any claimant having an objection to the Receiver's recommendations as set forth in the Receiver's Report filed in this proceeding on June 22, 2015, shall file such objection with this Court and serve a copy of the objection on the Receiver's counsel on or before **July 20, 2015**.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that, on or before **August 21, 2015**, the Receiver shall file with this Court his response to each timely filed objection to the Receiver's recommendations.

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the Receiver's Report, any timely filed objections to the Receiver's recommendations in the Receiver's Report, and any responses of the Receiver to such objections, are hereby set for hearing on Sept. 11<sup>th</sup>, 2015 at 9:00am before the Honorable Thomas E. Prince, Judge of the District Court.

**IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the Receiver serve the Notice by first class mail, postage prepaid, to each of the claimants whose claims are listed on Exhibits 1, 2, or 3 to the Receiver's Report, with an exhibit setting forth the Receiver's recommendation in respect to the relevant claim, to the claimant's address stated on the claimant's proof of claim, or the most recent address for the claimant on the records of the Receiver.




