**ORDER APPROVING RECEIVER'S FIRST REPORT ON CLAIMS
EVALUATION AND CONFIRMING RECEIVER'S RECOMMENDATION**

COMES ON for consideration the Receiver's First Report On Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed on July 22, 2015 ("Receiver's First Report"). The Receiver is present through counsel, Jason A. Reese, of the law firm of Meyer & Leonard, PLLC. No objections were filed, and no one appeared in opposition to the matter when it was called in open court on September 11, 2015. Having examined the Receiver's First Report, the Court finds as follows:

1. This Court established February 20, 2015, as the deadline for creditors to file proofs of claims against Red Rock Insurance Company. The Receiver has provided proper notice of these proceedings and the claim bar date to all persons or entities known to have a claim against Red Rock Insurance Company.

2. The Receiver's First Report informs the Court that thirty-one (31) Class 1 claims have been adjudicated, which have been approved by this Court pursuant to separate Order.

3. The Receiver's First Report informs the Court that thirty-six (36) Class 3 claims are ready for adjudication. Of those, the Receiver recommends that thirty-five (35) Class 3 claims be denied. The remaining claim, Claim No. 1205, has since been withdrawn by the Claimant, and such withdrawal is accepted by the Court.

4. The Receiver's First Report informs the Court that one (1) Class 6 claim is ready for adjudication. The Receiver recommends that this claim be allowed in the amount of \$224.05.


5. Having reviewed the Receiver's First Report, the Court finds that the recommendations made therein should be and hereby are approved. Pursuant to 36 O.S. § 1927.1, all Class 1 and Class 2 claims shall be paid in full prior to the payment of any other claim.
