ORDER APPROVING IN PART RECEIVER'S SECOND REPORT ON CLAIMS EVALUATION AND CONFIRMING RECEIVER'S RECOMMENDATIONS

On this 3rd day of March, 2016, comes on for consideration the Receiver's Second Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations filed on December 22, 2015 ("Receiver's Second Report"). The Receiver was present through counsel, Jason A. Reese, of the law firm of Meyer, Leonard & Edinger, PLLC, and no one appears in opposition. Having examined the Receiver's Second Report, the Court finds as follows:

- 1. The Receiver's Second Report informs the Court that 84 Class 3 claims, 13 Class 5 claims, 21 Class 6 claims, and 2 untimely-filed claims are ready for adjudication.
- 2. One timely objection was filed to the Receiver's Second Report (POC No. 1065, filed by The Surety & Fidelity Association of America). The Court by separate Order has provided for a briefing and hearing schedule with respect to POC No. 1065.
- 3. The Receiver withdrew its recommendation for POC No. 1304 filed by Foley & Lardner, PLLC.

4. The FDIC, as Receiver for various banking institutions, requested and was granted an extension of time to file an objection to 23 claims recommended for denial in the Receiver's Second Report. By separate Order, the Court granted the FDIC until March 7, 2016, to file its objections.

IT IS THERFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Second Report and the recommendations made therein are hereby approved, excluding with respect to POC Nos. 1065, 1304, and the 23 claims filed by the FDIC addressed in the Receiver's Second Report, which shall be adjudicated by separate Order(s).
