**ORDER APPROVING IN PART RECEIVER'S THIRD REPORT ON CLAIMS  
EVALUATION AND CONFIRMING RECEIVER'S RECOMMENDATIONS**

On this 5<sup>th</sup> day of August, 2016, comes on for consideration the Receiver's Third Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations filed on June 22, 2016 ("Receiver's Third Report"). The Receiver was present through counsel, Jason A. Reese, of the law firm of Meyer, Leonard & Edinger, PLLC, and no one appears in opposition. Having examined the Receiver's Third Report, the Court finds as follows:

1. The Receiver's Third Report informs the Court that 34 Class 3 claims are ready for adjudication.
