**ORDER APPROVING IN PART THE RECEIVER'S  
FIFTH REPORT ON CLAIMS EVALUATION**

On this 22<sup>nd</sup> day of September, 2017, comes on for consideration the Receiver's Fifth Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations filed on June 22, 2017 ("the Receiver's Fifth Report"). The Receiver was present through counsel, Ryan Leonard, of the law firm of Edinger, Leonard & Blakley, PLLC, and no one appears in opposition. Having examined the Receiver's Fifth Report, the Court finds as follows:

1. The Receiver's Fifth Report informs the Court that forty-five claims are ready for adjudication.
2. Two timely objections were filed by Claimants to the Receiver's Fifth Report (Proof of Claim Nos. 1115 and 1441). The Court by separate Order has provided for briefing and hearing schedules with respect to these two claims.
3. By previous Order, this Court has extended the deadline for objection on two additional claims (Proof of Claim Nos. 1342 and 1438) until September 26, 2017.
4. An objection was filed to the recommendation of Proof of Claim 1442 by a purported successor-in-interest to the claimant after the objection deadline. This Claim will be adjudicated by separate Order.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** that the Receiver's Fifth Report and the recommendations contained therein are hereby approved, excluding the recommendations with respect to Proof of Claim Nos. 1115, 1342, 1438, 1441 and 1442 which shall be adjudicated by separate Order(s).
