ORDER ESTABLISHING DEADLINES RELATING TO RECEIVER'S ELEVENTH REPORT ON CLAIMS EVALUATION AND SETTING HEARING DATE FOR RECEIVER'S ELEVENTH REPORT

On this 5th day of 500E, 2020, the Receiver's Eleventh Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendations ("Receiver's Eleventh Report") filed on June 4, 2020, comes before the undersigned Judge of the District Court. The Court, being fully advised of the premises and on good cause, finds and concludes that:

- (1) the Receiver shall provide notice or opportunity to object and be heard to each of the claimants making a claim evaluated in the Receiver's Eleventh Report, and the proposed form of notice attached as Exhibit 4 to the Receiver's Eleventh Report (the "Notice") is proper.
- (2) a date for filing an objection to the Receiver's recommendations should be established, and hearing date(s) scheduled.
- (3) the Receiver shall, upon the receipt of any objections to the recommendations contained in the Receiver's Eleventh Report, file with the Court a briefing and hearing schedule for each objection which may include a consolidated schedule to adjudicate multiple objections, where appropriate in the interest of judicial efficiency.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that any claimant having an objection to the Receiver's recommendations set forth in the Receiver's Eleventh Report filed on June 4, 2020, shall file such objection with this Court and serve a copy of the objection on the Receiver's counsel on or before July 24, 2020.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver's Eleventh Report, except as to all recommended claims as to which an objection is timely filed, is hereby set for hearing on July 31, 2020, at 9:00 am before the Honorable Thomas E. Prince, Judge of the District Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, on or before August 7, 2020, the Receiver shall file with this Court a briefing and hearing schedule for each claim to which an objection is timely filed.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Receiver serve the Notice by first class mail, postage prepaid, to each claimant whose claim is evaluated in the Receiver's Eleventh Report at the address listed in the proof of claim, unless the Receiver has received notice of a change of address.
