**RECEIVER'S FIFTEENTH REPORT ON CLAIMS EVALUATION**

COMES NOW, the State of Oklahoma, ex rel., Glen Mulready, Insurance Commissioner, as receiver for Red Rock Insurance Company, f/k/a BancInsure Inc., in liquidation (“Red Rock”) and Donna Wilson, Assistant Receiver (collectively, the “Receiver”), and files this Fifteenth Report on Claims Evaluation (the “Report”):

**BACKGROUND**

1. On August 21, 2014, this Court placed Red Rock in liquidation through its “Order Placing Insurer into Receivership and Liquidation, Appointing Receiver, and for Permanent Injunction.”

2. On October 24, 2014, the Court entered an order that approved the Receiver’s proposed Proof of Claim Form and accompanying instructions and established the claims filing deadline of February 20, 2015.

3. The Order of October 24, 2014, further established that the Receiver’s First Claims Evaluation and Request for Confirmation would be due on June 22, 2015, and that Supplemental

Claims Evaluations and Requests for Confirmation must be submitted within every six (6) months thereafter.

4. The Receiver continues to marshal all of the assets of Red Rock.
5. Court review and approval of the Receiver's recommendations regarding Class 1 claims occurs on a regular basis and Class 1 claims are therefore not included in this Report.
6. 431 proofs of claim, not including Class 1 claims, have been adjudicated to date.
7. The Receiver continues reviewing and analyzing claims but no additional claims are ready for adjudication at this time. As claims become ready for adjudication, the Receiver will file additional reports.
