NOTICE OF LIQUIDATION, PERMANENT INJUNCTION AND DEADLINE FOR FILING PROOF OF CLAIM

Notice is given that upon the Petition of John D. Doak, Insurance Commissioner, as Receiver for Red Rock Insurance Company f/k/a Bancinsure and the Application for Order Directing Insurer to Show Cause and the Order Directing Insurer to Show Cause, the District Court of Oklahoma County, Oklahoma, placed Red Rock Insurance Company f/k/a Bancinsure ("Red Rock") into receivership and ordered the liquidation of Red Rock Insurance Company on August 21, 2014.

In the Liquidation Order, the Court:

- 1. Enjoined and precluded Red Rock from conducting any further business;
- 2. Appointed John D. Doak, Insurance Commissioner, as Receiver of Red Rock;
- 3. Appointed Nestor Romero as Assistant Receiver for the Company,
- 4. Appointed the law firm of Riggs, Abney, Neal, Turpen, Orbison & Lewis, as Counsel for the Receiver,
- Ordered the assignment and vesting of title as well as the possession of all
 of Red Rock's assets in the Receiver.

Additionally, the Court ordered that policyholders, claimants and creditors having claims against Red Rock must file a proof of claim, together with proof of loss with the Assistant Receiver no later than February 20, 2015. Proof of Claim forms received after February 20, 2015 will lose their statutory priority and may not receive a distribution of assets.
