**ORDER APPROVING RECEIVER'S FIRST REPORT OF CLAIMS EVALUATION
AND CONFIRMING RECEIVER'S RECOMMENDATION**

On this 12th day of July, 2018 there came on for consideration the First Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed April 27, 2018. The Receiver was present through his Counsel, Ryan Leonard, of the law firm of Edinger, Leonard & Blakley, PLLC and no one appears in opposition. The Court having examined the Receiver's Report and being fully advised in the premises, finds and orders the following:

1. On June 27, 2017, this Court placed SeniorSure in liquidation through its Order Placing Insurer into Receivership and Liquidation, Appointing Receiver, and for Permanent Injunction ("Liquidation Order").

2. This Court established October 27, 2017 as the deadline by which creditors must file their proof of claims against the SeniorSure Health Plans, Inc. The Receiver has provided proper notice of these proceedings and the claims bar date to all known persons or entities known to have a claim against SeniorSure Health Plans, Inc. Any and all due process interests have been adequately protected by the Receiver's notices.

3. The Receiver's First Report informed the Court that One (1) timely Class 6 claim and One (1) untimely Class 6 claim are ready for adjudication. The Receiver's First Report detailed the Receiver's recommendation that each of the 2 claims in the Receiver's First Report be denied.

4. The Receiver gave proper notice to all claimants listed in the Receiver's First Report of an opportunity to object to the Receiver's recommendation for the denial of the claim by filing a written objection with the Court no later than June 29, 2018.

5. No written objections have been filed nor have any Claimants contacted Counsel or Receiver's office in opposition to the Receiver's First Report.


6. The Receiver's recommendation of the denial of the 2 Class 6 claims, as described in the Receiver's First Report should be and is hereby approved. All Class 1 – Class 5 Claims shall be paid in full prior to the payment of any Class 6, as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's First Report On Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed April 27, 2018, denying 2 Class 6 Claims is hereby approved in its entirety.


