

4. The Receiver gave proper notice to all claimants listed in the Receiver's Third Report of an opportunity to object to the Receiver's recommendations by filing a written objection with the Court no later than January 8, 2021.

5. No written objections have been filed nor have any Claimants contacted Counsel or Receiver's office in opposition to the Receiver's Third Report.

6. In the Third Report, the Receiver recommended that three (3) Class 6 claims be approved in part and denied in part, one (1) Class 6 claim be approved and one (1) Class 6 claim be denied. For good cause shown, the Court finds that the Receiver's recommendations as to all claims identified in the Third Report should be and hereby are approved. All Class 1 through Class 5 Claims shall be paid in full prior to the payment of any Class 6 Claims as provided by 36 O.S. § 1927.1.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's Third Report on Claims Evaluation and Request for Confirmation of Receiver's Recommendation filed October 26, 2020, is approved in its entirety.
