NOTICE OF LIQUIDATION, PERMANENT INJUNCTION AND DEADLINE FOR FILING PROOF OF CLAIM

Notice is given that upon the Petition of John D. Doak, Insurance Commissioner, as Receiver for SeniorSure HealthPlan, Inc. and the Application for Order of Receivership, and Order of Liquidation with Finding of Insolvency, the District Court of Oklahoma County, Oklahoma, placed SeniorSure HealthPlan, Inc. ("SeniorSure") into receivership and ordered the liquidation of SeniorSure on June 30, 2017.

In the Liquidation Order, the Court:

- 1. Enjoined and precluded SeniorSure from conducting any further business;
- 2. Appointed John D. Doak, as Insurance Commissioner, as Receiver of SeniorSure;
- 3. Appointed Donna Wilson as Assistant Receiver for the company;
- Appointed the law firm of Edinger, Leonard & Blakley, PLLC, as Counsel for the Receiver.
- Ordered the assignment and vesting of title as well as the possession of all of Pride's assets in the Receiver.

Additionally, the Court ordered that policy holders, claimants and creditors having claims against SeniorSure must file a proof of claim, together with proof of loss with the Assistant Receiver no later than October 27, 2017. Proof of Claim forms received after January 6, 2014, will lost their statutory priority and may not receive a distribution of assets.
